DURING FY21, IN RESPONSE TO COVID-19, THE FOOD PANTRY OPERATED AS A CHOICE DRIVE-THRU PANTRY, ALLOWING GUESTS TO CHOOSE ITEMS THROUGH A MENU SYSTEM, INCLUDING FRESH PRODUCE, AMPLE PROTEIN OPTIONS AND DAIRY, IN ADDITION TO PANTRY STAPLES AND PERSONAL CARE ITEMS. IN ADDITION, THE FOOD SECURITY PROGRAM RESPONDED TO EMERGING AND SHIFTING NEEDS IN THE FOOD SECURITY SYSTEM THROUGHOUT THE YEAR, PARTNERING WITH AREA ORGANIZATIONS AND TARGETING IDENTIFIED NEEDS IN SPECIFIC AREAS OF THE COMMUNITY. MOM STAFF ALSO PARTICIPATED IN
